### Volunteers Needed 1

The SROA is looking for two volunteers (one for Cape LaBelle and one for Lyman Lake) to assist the board in their efforts to address violations of the bylaws and covenants.

Please note this all for the betterment of our community with regard to safety and esthetics.

Tasks for this role include a monthly drive around SROA (noninvasive, not going onto lots) and report any obvious long term or new violations. Also drive by recently approved building structure lots to insure they are in compliance with the bylaws and covenants. Create a monthly report for the Board so they can address violations appropriately.



Speeding – all motorized vehicles must be aware speeding has been an ongoing issue. There are more people living here, and this time of year there is an increase in people driving as well as pedestrians (many take walks with children and pets) on our roads, so it must be addressed again

Please for the safety of your neighbors, guests, and friends Slow Down! The speed limit is 15 MPH on all Sun Ranch roads. Note - it is not safe to pass a moving vehicle on any SROA road.

#### **Shooting**

No shooting or hunting is allowed in common areas. Target shooting at night is illegal, even on your own property.

#### **Illegal and Suspicious Activity**

Report all illegal and/or suspicious activity to the Sheriff's office NOT a board member. We have no authority to stop crime done or in progress. You can email us at sunranchmemberstonasket@gmail.com as an FYI so we can be aware inform other members as needed where crime is happening.



Please be aware of easements and common areas and do not put personal lot signage, fencing or structures on easement or on common areas. Easement is aprox 30 feet from the center of roads. Common areas are marked in most cases, or you can review on the SORA maps, which are available on the website. Please contact a board member if you have any questions in this regard.



Wild animals cannot be controlled by the board. Do not call a board member because you're having an issue with any species of wild animal. Call the Sheriff for advice but be aware they no longer have an animal control deputy.

It is that time of year again....please be a Conscientious Neighbor and Wildfire Ready.

We would like to remind our members that fire season will be upon us soon enough. Our weather in the Okanogan gets drier each year, creating ever-threatening wildfire seasons. Remember last year and how close the fires were to SROA properties, many were on stand-by to evacuate last year. It is important that we all keep our properties tidy and clear of limb piles, garbage, underbrush, derelict cars, etc.

For our members who do not live in the valley and/or rarely visit your property, you still have a responsibility to maintain a fire-safe lot. This includes mowing tall grass, limbing and thinning your trees and disposing of the slash.

When you fall or limb your trees, be sure to do it between November and February, when sap is not flowing or when beetles are dormant. Limb them up high enough so if a fire comes through the tree limbs won't catch fire. Cut into slash piles and burn slash piles during the cold/winter season. Do not burn during the spring through fall—March through October—because fallen logs and slash piles attract beetles. Slash piles should never be placed under or near trees; always place them in an open area, make smallish piles of slash; flames from large piles have been known to scorch the branches all the way up on even super-tall trees, which compromises the health of the trees, which attracts beetles, as well.

If you are unable to do the necessary work yourself there are reliable people in the area who you can hire to do this type of work, including tree limbing, thinning, removal, and burning. Beetles - If you are unsure if there is an infestation of beetles on your property contact the DNR they will come out and assess your trees and contact you with the results. DNR has stewardship foresters within most parts of Washington that can assist landowners to improve the health of their forests www.dnr.wa.gov/sflo.
